

TERMS AND CONDITIONS of the "Bonus Warmup" special action

These terms and conditions define the rights and conditions of participation in the promotional action "Summer-Bonuses" (hereinafter referred to as the "Action"), which is organized by INIS sp. z o.o. based in Rybnik ("INIS").

- 1. The Action is intended for existing partners of the INIS affiliate network and partners who will join the network during the Action.
- 2. Partners from the category of: affiliate networks, intermediaries and entities that do not have their own advertising placements are excluded from the Action. Regardless of the sales performed during the time period of the Action, the bonus will not be paid to partners from the mentioned categories.
- 3. The duration of the Action is 2 months, i.e. from 01.05.2024 to 30.06.2024.
- 4. The Action consists in awarding an additional financial bonus to those affiliates (excluding affiliates excluded in accordance with section 2 above) who generate additional numbers of orders for affiliate programs selected and indicated by INIS during the whole period of the Action.
- 5. Additional orders shall be understood as the total amount of orders/sales during the period of the Action on all programs covered by the additional bonus only in CPS (cost per sale) or CPO (cost per order) models. The condition for the sales/orders to be counted as part of the Action is that they must be accepted by the advertiser who owns the given affiliate program under the terms and conditions indicated in that program.
- 6. The additional bonus shall consist in the payment of a cash bonus to the affiliate partner in the amount shown in the bonus table indicated in Section 10 (Bonus Table 1).
- 7. The payment of the additional bonus will be made in the next billing period following the end of the Action, but not earlier than the approval of sales by advertisers.
- 8. To join the Action you must:
 - (a) be an active publisher of the INIS affiliate network,
 - b) apply for participation in the Action to your INIS account or by email to wydawcy@inis.pl during the bonus action,
 - c) actively promote at least 5 Programs covered by the additional bonus indicated in the action.
